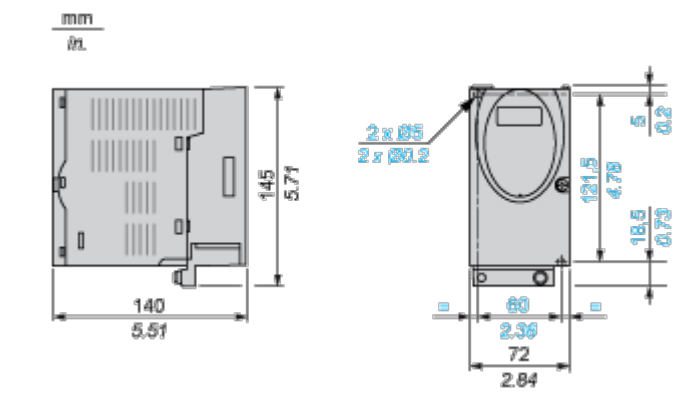

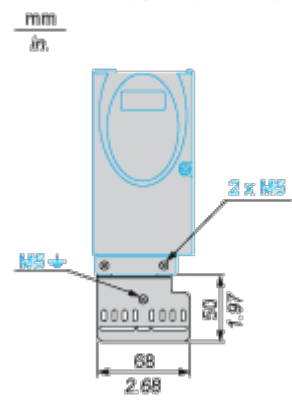

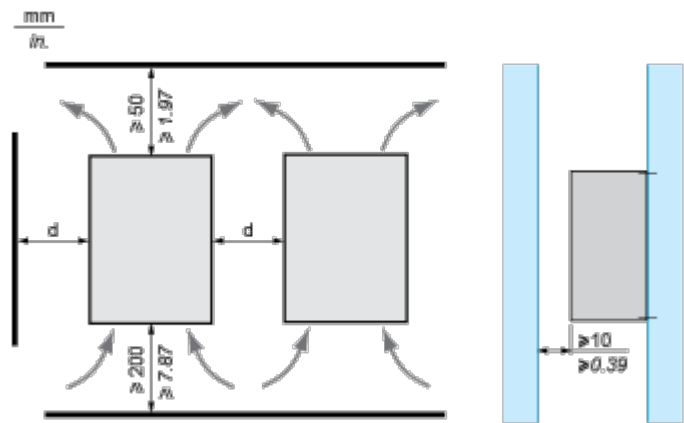


EMC mounting plate (included)

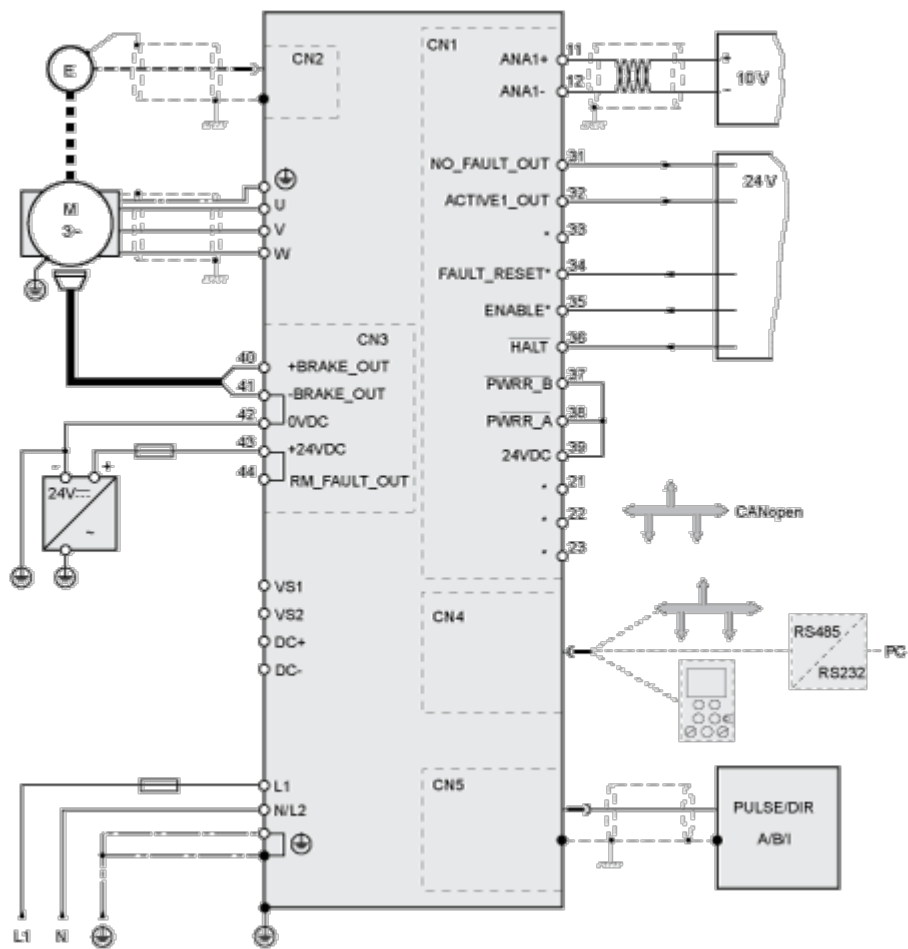

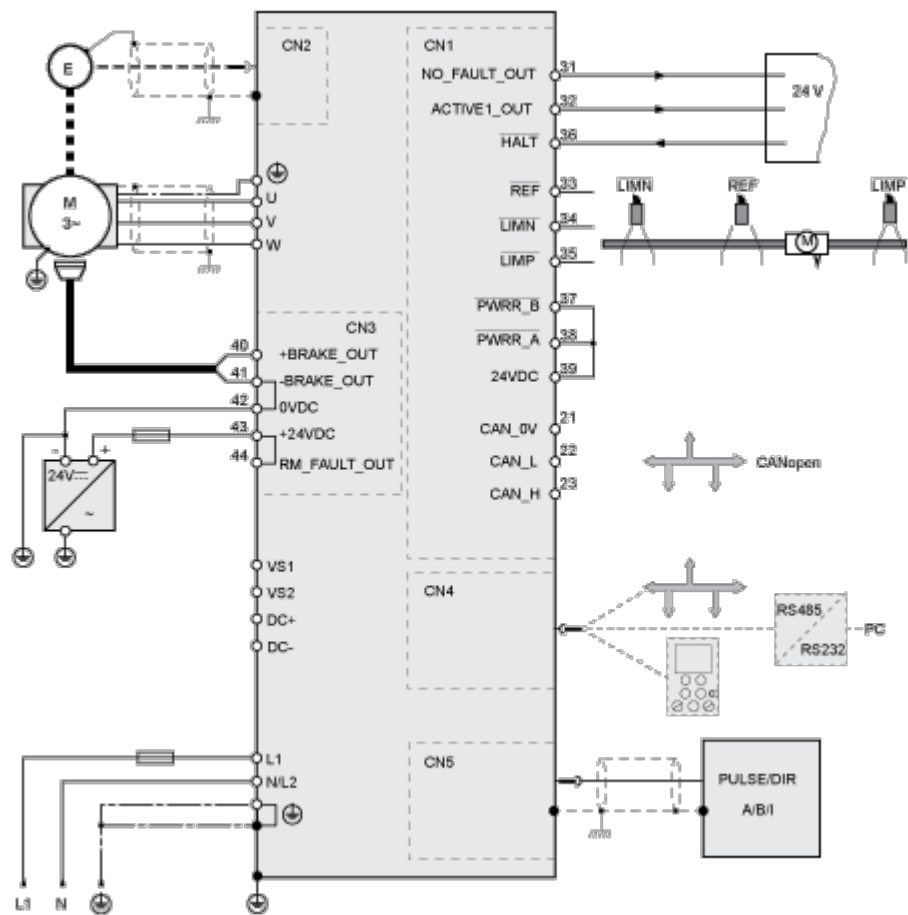

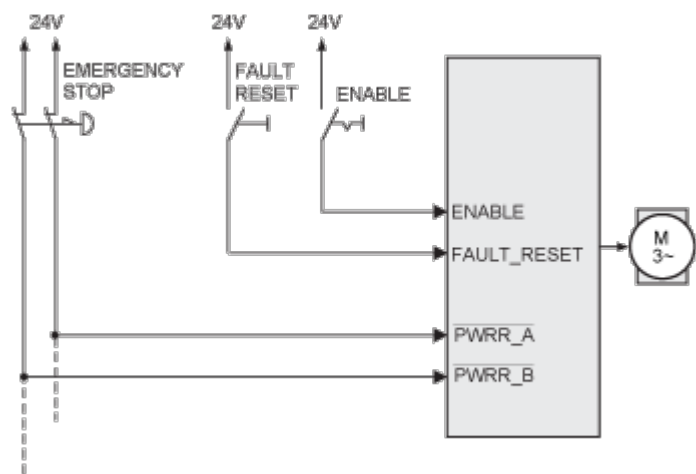
SD328A Connection Example with Local Control
