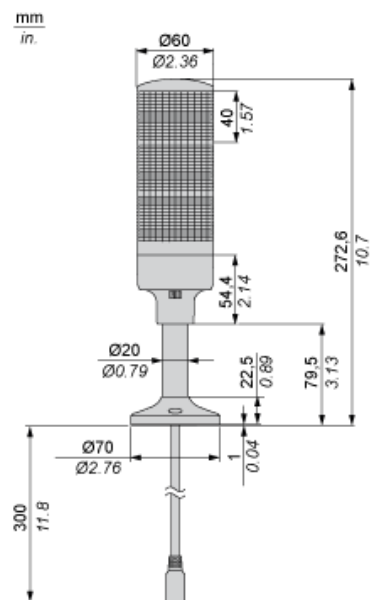

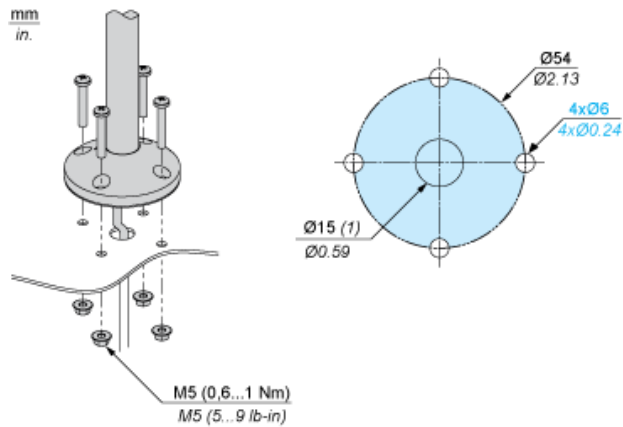

Tube Mounting with Fixing Plate

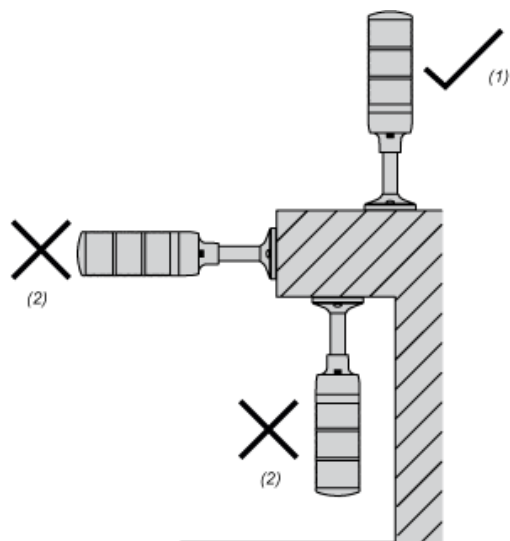


Mounting on Horizontal Support for Tube Mounting with Fixing Plate
